1. What are JA Québec Educational Programs?

JA Québec Educational Programs is a non-profit organization (formerly known as Young Enterprises of Quebec) that has been inspiring and preparing young people to succeed in a global economy since 1962. These programs focus on financial literacy, career readiness, and entrepreneurship, helping young people develop the skills needed for their professional future and to achieve better financial health.

2. What skills are developed by JA Québec programs?

- Financial literacy
- Personal and career orientation
- Entrepreneurship awareness

3. What do I contribute to by making a donation? How do JA Québec programs work?

JA Québec programs are offered to young people by business professionals and aim to provide them with tools to help them make sound financial decisions, choose the right career path, and/or start a business.





Students are encouraged to discover their roles as individuals, entrepreneurs, workers, and consumers, and to address key issues related to the economy and the job market. Business volunteers are trained by JA Québec to deliver the programs in schools for free, either during or after school hours.

The School Programs are delivered to students in the classroom during the day, over a period of 4 to 6 hours, in a format of 4 or 5 workshops using game boxes and tactile and multimedia educational tools.

The Company Program is offered as an after-school activity, one evening a week for 3 hours. In some schools, the Student Enterprise program is also offered during school hours.

4. Will I receive a tax receipt if I buy a ticket for the CFA Montréal INVESPACT event?

Yes, when you purchase a ticket for the CFA Montréal Investpact event, you are eligible to receive a tax receipt. This receipt is issued by JA Québec for the portion of the ticket price that exceeds the value of the benefits received during the event.

5. How is the tax receipt amount calculated?

The tax receipt amount is calculated by subtracting the value of the goods and services received during the event from the total amount paid for the ticket. For example, if the ticket costs \$100 and the value of the services received is \$50, the eligible amount for the tax receipt would be \$50. The value of your donation (and the tax receipt amount) will be calculated after the event, receipts will be issued thereafter.

6. How will the funds raised at the business event for the benefit of JA Québec Educational Programs be used?

Donations from supporters and profits generated by the InvestPact event will be used to support and develop JA Québec initiatives. This includes funding educational programs aimed at strengthening young people's skills in financial literacy, leadership, and entrepreneurship, as well as providing them with the tools they need to succeed in the global economy.
